 - Participant 1: (UFL, Monroe County): survey of 107 small-medium sized communities;
 good mix of respondents (size and politically); heard what you expect no political will,
 no staff time/resources, no \$

- Do you feel like there was an opening in some of those conversations about where to start, if you were going to? Yes, used to develop tool to help communities work on resilience
- Lots of \$ for vulnerability studies and action plan -> required first step for \$ to pay for shovel-ready projects; lots of communities are trying to pursue
- Considering taking what counties have done and tailoring it down to help under-resourced communities
- Participant 2 (Southeastern MN): Q For clarity, what are we considering small and midsized populations? Is there a difference in what rural means?
 - 70K and under considered rural; ASAP will follow-up
- Participant 3- why does definition of rural matter?
 - Have worked mostly in NE NY, 90-95% of what we're talking about re: climate change is true for everything for rural communities
 - What do people care about? How do we attach climate-related issues to those issues?
 - E.g. housing, housing affordability could be point of entry (already something people care about), could be helpful for framing

 - Cole McMahon (facilitator): Agree completely
- Participant 3, SCA: from our members and partners we're hearing a lot of interest in wildfire
 prevention/restoration, historic preservation, wildlife conservation, GIS/mapping, orphan well
 capping/restoration, etc.
- Participant 3: Many also need help formulating projects that they would benefit from, ie community engagement at front end.
